

## **Official Rules for 2017 United Way of the Tanana Valley 100,000 Miles Sweepstakes**

Donors will be automatically entered to win the sweepstakes if their gift meets the following criteria:

1. Annual gift to United Way of the Tanana Valley is increased by at least \$50 or is a first time gift to United Way of the Tanana Valley of at least \$50,
2. Gift is made using a United Way of Tanana Valley pledge form, or via an electronic pledge system,
3. Pledge form or electronic submission is received by December 31, 2017

Sweepstakes will commence on August 1, 2017. To qualify, all sweepstakes entry forms must be received by 4:00 pm on December 31, 2017 at 818 26<sup>th</sup> Ave. #2, Fairbanks, Ak, 99701.

No donation is necessary to enter or win. A donation will not increase the chances of winning. A manual entry form will be available during the sweepstakes by sending a request and a self-addressed stamped envelope to United Way of the Tanana Valley, PO BOX 74396, Fairbanks, Ak, 99707. Entrants must have their principal residence or their principal place of employment in Alaska.

Limit one entry per person.

The odds of winning shall be determined based upon the number of valid entries received.

Sweepstakes void where prohibited or restricted by law.

Illegible entries will be disqualified.

All prizewinners must meet the following qualifications:

- Be at least 18 years of age on or before January 31, 2018. Winner must provide proof of age.
- The winner will be required to sign a Waiver Sheet/Release Form, provide his/her social security number, and claim prize within ten (10) days of notification.
- The winner releases United Way of the Tanana Valley, subsidiaries, suppliers, advertisers and promotion agencies, respective employers and agents from any and all liability arising out of participation in this game.
- The acceptance of a prize constitutes permission to use the winner's name or likeness for the purpose of advertising, promotion and trade in connection with United Way of the Tanana Valley without further compensations.

On January 31, 2018 finalists will be randomly drawn from all eligible entries received by 4:00 p.m. December 31, 2017.

The random drawing will be supervised by United Way of the Tanana Valley officials whose decisions are final with respect to all matters related to this sweepstakes.

Winner will be notified in person, by phone, email or registered mail. In the event that United Way of the Tanana Valley is unable to contact the winner, despite reasonable efforts to do so, an alternate winner will be chosen. In the event that the winner is not qualified to accept the prize, an alternate winner will be chosen. Board Members of United Ways in Alaska and their immediate families and other household members and employees of United Ways in Alaska and their immediate families and other household members are not eligible.
